Contestant Agreement, Waiver and Release

Qualifying Competition

- Contestants must submit a completed entry form, in person.
- Contestants are limited to individuals 21 years and over.
- All contestants must be amateur entertainers.
- No instruments allowed.
- No Entry Fee. However, food/beverage purchase is necessary.
- Order of performance will be determined randomly.
- All participants must give Peekskill Public Kitchen and Bar and its affiliates permission to use their name, photo and video recording for any promotional activities.
- Although duos/duets are permitted, no more than 2 individuals may perform together. A duo/duet counts as one contestant; therefore, any prize received will be provided to both together, not individually. Duos must determine how to split the prize, as this is not the responsibility of the DJ or Peekskill Public Kitchen and Bar.
- Each week, one winner will be selected and will be determined by audience applause (Karaoke DJ and judges will determine the winner if too close to call) to move on to the Finals.
- Winners of weekly qualifying competitions cannot enter to participate in the weekly contest again.
- The Judge's decision is final.
- Contestants must be Present to Win.

Finals

- All winners who have advanced to the finals must be in attendance on the final night of the qualifying competitions.
- Each contestant must limit their performance to two songs, which will be randomly selected from a collection of song suggestions anonymously submitted to the DJ by the audience in attendance on the last qualifying competition night.
- Finalists will have one week to practice their selected songs at the finale.
- Winner will be determined by audience applause (Karaoke DJ and judges will determine the winner if too close to call).
- Between the qualifying contestants, there will only be one grand prize winner.

Winners

- One winner of the qualifying competitions will be selected each week leading up to the Finals and will receive \$100 in cash.
- Grand Prize winner of the Finals (1) will receive \$1,000.00 in cash.
